

RESOLUTION

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE EMMETT INDEPENDENT SCHOOL DISTRICT NO. 221, GEM AND BOISE COUNTIES, IDAHO, ORDERING A SPECIAL ELECTION TO BE HELD ON THE QUESTION OF AUTHORIZING A SUPPLEMENTAL LEVY IN THE AMOUNT OF SIX HUNDRED THOUSAND DOLLARS (\$600,000) FOR TWO YEARS; ORDERING A SPECIAL ELECTION TO BE HELD ON THE QUESTION OF AUTHORIZING A SUPPLEMENTAL LEVY IN THE AMOUNT OF FOUR HUNDRED THOUSAND DOLLARS (\$400,000) FOR TWO YEARS; APPROVING THE FORM OF BALLOTS; PROVIDING FOR REGISTRATION OF ELECTORS; AND PROVIDING FOR OTHER MATTERS RELATING THERETO

WHEREAS, the Emmett Independent School District No. 221, Gem and Boise Counties, Idaho (the "District"), is a school district created and operating under the laws of the State of Idaho;

WHEREAS, in the opinion of the Board of Trustees (the "Board") of the District, there is a need for the District to raise additional revenues by means of a supplemental levy in the amount of \$600,000 for two fiscal years; and

WHEREAS, in the opinion of the Board of Trustees (the "Board") of the District, there is a need for the District to raise additional revenues by means of a supplemental levy in the amount of \$400,000 for two fiscal years; and

WHEREAS, the District is required, pursuant to Section 33-802(3), Idaho Code, to submit the questions of authorizing the supplemental levies in a specified amount and for a specified time, each not exceeding two years, to the electors of the District.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF EMMETT INDEPENDENT SCHOOL DISTRICT NO. 221, Gem and Boise Counties, Idaho, as follows:

Section 1: A special election is hereby called to be held within the District on Tuesday, May 16, 2023, for the purpose of submitting to the qualified electors of the District the question set forth in the form of ballot appearing in Section 6 hereof and the question set forth in the form of the ballot appearing in Section 7 hereof.

Section 2: The special election shall be held as specified in Title 33, Chapter 4, Idaho Code, by Gem and Boise Counties and conducted by the Gem and Boise County Clerks.

Section 3: The polls of the special election shall open at the hour of 8:00 o'clock a.m. on May 16, 2023, and shall remain open continuously until the hour of 8:00 o'clock p.m., at which time the polls shall be closed.

Section 4: Each person voting at the special election shall be, at the time of the election, a qualified elector of the District, within the meaning of Article 6, Section 2, of the Idaho Constitution, and Section 33-405, Idaho Code, eighteen (18) years of age or older, properly

registered, and a United States citizen who has resided in the State of Idaho and in the District at least thirty (30) days next preceding the election.

Section 5: Electors must, in order to vote at the special election, be registered to vote according to the respective registration records of Gem and Boise Counties, Idaho, as required by Sections 33-405 and 34-404, Idaho Code.

Section 6: The first ballot proposition for the special election shall be in substantially the following form:

The levy shall be used for the Carberry and Shadow roof removal and replacement, building entry updates, lighting and security cameras, interior door ADA compliant hardware, and other maintenance items of the District. The estimated average annual cost to the taxpayer on the proposed levy is a tax of \$20.98 per \$100,000 of taxable assessed value, per year, based on current conditions. The District has an existing levy that will expire on June 30, 2023 and currently costs \$35 per \$100,000 of taxable assessed value.

Question: Shall the Board of Trustees of the Emmett Independent School District No. 221, Gem and Boise Counties, State of Idaho, be authorized and empowered to levy a supplemental levy in the amount of Six Hundred Thousand Dollars (\$600,000) per year for two (2) years commencing with the fiscal year beginning July 1, 2023 and ending June 30, 2025, for the purpose of funding lawful expenses of maintaining and operating the District?

Section 7: The second ballot proposition for the special election shall be in substantially the following form:

The levy shall be used to support current staffing levels and provide additional support for special education and counseling. The estimated average annual cost to the taxpayer on the proposed levy is a tax of \$13.99 per \$100,000 of taxable assessed value, per year, based on current conditions. The District has an existing levy that will expire on June 30, 2023 and currently costs \$35 per \$100,000 of taxable assessed value.

Question: Shall the Board of Trustees of the Emmett Independent School District No. 221, Gem and Boise Counties, State of Idaho, be authorized and empowered to levy a supplemental levy in the amount of Four Hundred Thousand Dollars (\$400,000) per year for two (2) years commencing with the fiscal year beginning July 1, 2023 and ending June 30, 2025, for the purpose of funding lawful expenses of maintaining and operating the District?

Section 8: Notice of the special election shall be given prior to said election by publishing the notice of such election in a newspaper having general circulation within the District as set forth in Title 33, Chapter 4, and Title 34, Chapter 14, Idaho Code.

Section 9: Any qualified and registered elector of the District may vote by absentee ballot in the manner provided by Idaho Code Section 33-406, as amended.

Section 10: When the polls are closed, the election officials shall immediately proceed to count the ballots cast at the special bond election. The counting shall be continued without adjournment until completed and the result declared. The election judge and clerks shall thereupon certify the returns of the special bond election to the respective Gem and Boise County Clerks, who shall present the results to the respective Gem and Boise Counties Commissioners.

The Board of County Commissioners for Gem and Boise Counties shall meet within ten (10) days following the election, or at such time to which said meeting is continued, for the purpose of canvassing the results of the special bond election. The Gem and Boise County Clerks for the respective County shall thereupon certify the election results to the District Clerk.

Section 11: The officers of the District and Gem and Boise Counties are hereby authorized and directed to take all action necessary or appropriate to effectuate the provisions of this Resolution.

Section 12: This resolution shall take effect and be in force immediately upon its passage and approval.
